AGREEMENT OF ASSUMPTION OF RISK, RELEASE AND WAIVER FROM LIABILITY, AND INDEMNIFICATION

I also understand and agree that if behavior of my child becomes a problem, my child will be sent home immediately at my expense.
- I hereby release, waive and discharge LGPC, its trustees, elders, employees, agents, volunteers and representatives from any and all claims, 3. demands, losses or damages on account of any injury, death, or damage to person or property, arising out of the participation of my child in LGPC activities, whether on LGPC premises or elsewhere.
- I also hereby agree to hold harmless, defend and indemnify LGPC and all persons mentioned in point 3 from any claim or demand, including 4. attorney fees, made on account of injury or damage which my child may suffer as a result of participation in LGPC activities.
- 5. I understand that this release, waiver and agreement to indemnify and hold harmless includes, but is not limited to damages which are caused or alleged to be caused in whole or in part by the negligence of LGPC or the individuals listed in point 3.
